The Skiving Operation is a critical operation in goods and garments manufacturing. Skiving is done along the edges of the material, so that it can be folded and pasted with easy and accuracy. This operation greatly influences the appearance of the Goods & Garments

**Brief Job Description:** The Skiving operator must be capable to operate skiving machines and also skilful to perform skiving with accuracy according to the specifications. Skiving operator must also be capable to perform the maintenance of the grinder and the skiving disk knife.

**Personal Attributes:** The Skiving Operator must possess, concentration, good eye-hand co-ordination, monitoring ability, vision (including near vision, distance vision, colour vision, peripheral vision), depth perception, quick response time or reflex, physical fitness, target oriented as well basic estimation and numerical skills.
